Volunteer Release and Waiver Liability

This Release and Waiver of Liability (the "release") executed on (date) _____ by (name of the volunteer) ("Volunteer") releases the Archdiocese of San Antonio, a nonprofit corporation organized and existing under the laws of the State of Texas and each of its directors, officers, employees, and agents. The Volunteer desires to provide volunteer services for the Archdiocese of San Antonio and engage in activities related to serving as a volunteer.

Volunteer understands that the scope of Volunteer's relationship with the Archdiocese of San Antonio is limited to a volunteer position and that no compensation is expected in return for services provided by Volunteer; that the Archdiocese of San Antonio will not provide any benefits traditionally associated with employment to Volunteer; and that Volunteer is responsible for his/her own insurance coverage in the event of personal injury or illness as a result of Volunteer's services to the Archdiocese of San Antonio.

1. **Waiver and Release:** I, the Volunteer, release and forever discharge and hold harmless, the Archdiocese of San Antonio and its successors and assignees from any and all liability, claims, and demands of whatever kind or nature, either in law or in equity, which arise or may hereafter arise from services I provide to the Archdiocese of San Antonio. I understand and acknowledge that this Release discharges the Archdiocese of San Antonio from any liability or claim that I may have against the Archdiocese of San Antonio with respect to bodily injury, personal injury, illness, death, or property damage that may result from services I provide to the Archdiocese of San Antonio or occurring while I am providing volunteer services.
2. **Insurance:** Further I understand that the Archdiocese of San Antonio does not assume any responsibility for or obligation to provide me with financial or other assistance, including but not limited to medical, health or disability benefits or insurance of any nature in the event of my injury, illness, death or damage to my property. I expressly waive any such claim for compensation or liability on the part of the Archdiocese of San Antonio beyond what may be offered freely by the Archdiocese of San Antonio in the event of such injury or medical expenses incurred by me.
3. **Medical Treatment:** I hereby Release and forever discharge the Archdiocese of San Antonio from any claim whatsoever which arises or may hereafter arise on account of any first-aid treatment or other medical services rendered in connection with an emergency during my tenure as a volunteer with the Archdiocese of San Antonio.
4. **Assumption of Risk:** I understand that the services I provide to the Archdiocese of San Antonio may include activities that may be hazardous to me including, but not limited to loading and unloading, packing items, interaction with clients, and other various activities. As a volunteer, I hereby expressly assume the risk of injury or harm these activities and Release the Archdiocese of San Antonio from all liability for injury, illness, death, or property damage resulting from the services I provide as a volunteer or occurring while I am providing volunteer services.
5. **Other:** As a volunteer, I expressly agree that this Release is intended to be as broad and inclusive as permitted by the laws of the State of Texas and that this Release shall be governed by and interpreted in accordance with the laws of the State of Texas. I agree that in the event that any clause or provision of this Release is deemed invalid, the enforceability of the remaining provisions of this Release shall not be affected.
